Residential: New residential construction, additions, and accessory buildings to a residence, and modular homes.

Permit Fee:	\$10.00
Plan Review Fee:	Per IBTS Contract or use of Registered Third Party Provider
Inspection Fee:	Per IBTS Contract or use of Registered Third Party Provider

Residential: Other – Swimming pools, water heater replacements, re-roofing, temporary power poles other than those associated with new construction, or other HVAC, plumbing, or electrical changes, etc.

Permit Fee:	\$10.00
Inspection Fees:	<u>\$15.00</u>
Maximum Total Cost:	\$25.00

Manufactured / Mobile Home: Utility connections to manufactured homes

Permit Fee:	\$10.00
Inspection Fees:	<u>\$20.00</u>
Maximum Total Cost:	\$30.00

Commercial: New construction (including modular buildings)

Permit Fee:	\$25.00
Plan Review:	Per IBTS Contract or use of Registered Third Party Provider
Inspection Fee:	Per IBTS Contract or use of Registered Third Party Provider

Commercial: Additions or alterations to existing buildings

Permit Fee:	\$10.00
Plan Review:	Per IBTS Contract or use of Registered Third Party Provider
Inspection Fees:	Per IBTS Contract or use of Registered Third Party Provider

Commercial: Other - Signs, water heater replacements, re-roofing, temporary power poles other than those associated with new construction, or other HVAC, plumbing, or electrical changes, etc.
