## Ward Four FPD Minutes, October 29, 2018

A regular meeting of the Ward Four Fire Protection District of Jackson Parish was called to order at 7:00 p.m., on October 29,2018, at the fire district's Central Station, located at 261 Hwy 505, Jonesboro, LA. This meeting was called to order by Kent Hightower, fire district board president.
