Motion Mr. Bagwell, second Mr. Carpenter to approve minutes for March 16, 2017. Motion carried.

Motion Mr. Bagwell, second Mr. Carpenter to approve payment of bills. Motion carried.

Motion Mr. Carpenter, second Mr. Bagwell to approve a request from Mr. Paul Florence, Jimmy Davis State Park, to incorporate additional area for swimming. Area will be marked with buoys to protect the swimmers from lake traffic. Motion carried.
