WHEREAS, the governing authority of the District has requested that this Police Jury, acting as the governing authority of the Parish of Jackson, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Police Jury to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Jackson, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of the Jackson Parish Hospital Service District, Jackson Parish, Louisiana, this Police Jury hereby approves the

holding of an election in the District, on Saturday, November 18, 2017, at which election there will be submitted the following proposition, to-wit:

PROPOSITION

(MILLAGE CONTINUATION)

Shall the Jackson Parish Hospital Service District, Jackson Parish, Louisiana (the "District"), be authorized to continue to levy an ad valorem tax of eleven and thirty-one hundredths (11.31) mills on all property subject to taxation in the District (an estimated \$2,562,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028, to be dedicated and used for the purpose of maintaining and operating the District's hospital facilities and for purchasing necessary hospital equipment, said millage to represent a one and thirty-one hundredths mills (1.31) increase over the 10 mills tax authorized to be levied through the year 2018 pursuant to an election held on July 21, 2007?

SECTION 2. In the event the election carries, this Police Jury does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.
