

The Jackson Parish Police Jury met Monday, August 29, 2016, at 5:30 PM, in the Police Jury Meeting Room of the Jackson Parish Courthouse. Members present: Todd Culpepper, Eddie Langston, Amy Magee, John McCarty, Regina Rowe and Lynn Treadway. Absent: Maxie Monroe.

The meeting was called to order by the president, Mr. Culpepper. Mr. McCarty gave the invocation and Mr. Treadway led the recitation of the Pledge of Allegiance.

The following amendments to the agenda were offered:

Motion Mr. Langston seconded Mr. Treadway to approve the quotation of Abatement Services, Inc. in the amount of \$20,000 to abate asbestos in three mechanical rooms of the courthouse. Motion carried.
