The Jackson Parish Police Jury met in regular session Monday, July 11, 2016, at 5:30 P.M. in the Dr. Charles H. Garrett Community Center, 182 Industrial Drive, Jonesboro, Louisiana. Members present: Todd Culpepper, Eddie Langston, Amy Magee, John McCarty, Maxie Monroe, Regina Rowe and Lynn Treadway. Also present: Darrell Avery, Assistant District Attorney.

Mr. Culpepper called the meeting to order and gave the invocation. Ms. Magee led the recitation of the Pledge of Allegiance.

The president opened the floor for public comments.

The president called for committee reports.

Mr. Langston gave the report of the Solid Waste Committee.

"Solid Waste Committee June 27, 2016

The Solid Waste Committee met Monday, June 27, 2016, at 4:45 PM in the Police Jury Meeting Room. Members present: Mr. Langston, Ms. Rowe and Mr. Treadway. Also present: Ms. Magee and Mr. McCarty, Mr. Culpepper and Ms. Monroe.

The chairman, Mr. Langston called the meeting to order and gave the invocation. Ms. Rowe led the recitation of the Pledge of Allegiance.

Mr. Treadway requested that the agenda be amended to include waiving fees for solid waste disposal for cemeteries and churches. There were no comments on the amendment.
