Robert Austin, LSU Extension Agent introduced Ms. Kayla McGuire, the new 4-H Agent for the parish.

Motion Ms. Monroe seconded Ms. Magee to approve the minutes of the January 11, 2016, January 15, 2016 jury meetings, the January financial report and the payment of all bills. Motion carried.

The president called for committee reports and gave the report of the Finance Committee.
