RESOLUTION

A resolution approving the holding of an election in Hodge Fire Protection District #1 of the Parish of Jackson, State of Louisiana, on Saturday, March 28, 2015, to authorize the levy of a parcel fee therein.

WHEREAS, the Board of Commissioners of Hodge Fire Protection District #1 of the Parish of Jackson, State of Louisiana (the "Governing Authority"), acting as the governing authority of Hodge Fire Protection District #1 of the Parish of Jackson, State of Louisiana (the "District"), adopted a resolution on October 20, 2014, calling a special election in the District on Saturday, March 28, 2015, to authorize the levy of a parcel fee therein; and

WHEREAS, the governing authority of the District has requested that this Police Jury, acting as the governing authority of the Parish of Jackson, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the parcel fee provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Police Jury to approve the holding of said election and in the event that the election carries, to levy and collect the parcel fee provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Jackson, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Hodge Fire Protection District #1 of the Parish of Jackson, State of Louisiana, this Police Jury hereby approves the holding of an election in the District, on Saturday, March 28, 2015, at which election there will be submitted the following proposition, to-wit:

PROPOSITION

(PARCEL FEE RENEWAL)

Shall Hodge Fire Protection District #1 of the Parish of Jackson, State of Louisiana (the "District"), levy and collect annually for a period of ten (10) years, beginning with the year 2016 and ending with the year 2025, a parcel fee on each parcel of immovable property as defined in Louisiana Revised Statute 40:1505 (D) situated within the District, in the amount of \$72.00 per year (an estimated \$55,800 reasonably expected at this time to be collected from the levy of the tax for an entire year), to be expended for the purposes of acquiring, constructing, maintaining and operating fire protection facilities and equipment, including the cost of obtaining water for fire protection purposes and salaries of firemen, and all purposes incidental thereto?

SECTION 2. In the event the election carries, this Police Jury does hereby further consent to and authorize the District to levy and collect the parcel fee provided for therein.
