Members present: Todd Culpepper, Eddie Langston, Billy Bryant, Maxie Monroe and Lynn Treadway. Absent: Josh Peterson and Charles Garrett. Also present: Douglas Stokes, Assistant District Attorney.

The meeting was called to order by the president, Mr. Culpepper. The invocation was given by Mr. Treadway and Mr. Bryant led the recitation of the Pledge of Allegiance.

The President declared the Board of Review for the 2014 Assessment to be in session.
