

The Jackson Parish Police Jury met in special session Monday, August 4, 2014, at 5:30 PM in the Dr. Charles H. Garrett Community Center, 182 Industrial Drive, Jonesboro, Louisiana. Members present: Mr. Todd Culpepper, Mr. Eddie Langston, Mr. Billy Bryant, Ms. Maxie Monroe, Mr. Charles Garrett and Mr. Lynn Treadway. Absent: Mr. Josh Peterson.

The meeting was called to order by the president, Mr. Culpepper. Ms. Monroe gave the invocation and Mr. Treadway led the recitation of the Pledge of Allegiance.

The president called for public comments; there were none.

**ORDINANCE 01-0804-2014**

**AN ORDINANCE PROVIDING FOR THE MERGER AND/OR CONSOLIDATION OF CERTAIN VOTING PRECINCTS PURSUANT TO LA. R.S. 18:532.1**

**WHEREAS**, the Jackson Parish Police Jury is required to maintain polling places in said Parish, and

**WHEREAS**, the below precincts have less than 300 active registered voters, and

**WHEREAS**, the below precincts create additional expenses for the citizens of Jackson Parish, and

**WHEREAS**, Louisiana State Law allows for the merging or consolidation of certain precincts; and

**WHEREAS**, the following is a list of precincts merged or consolidated to reduce the cost of elections in Jackson Parish:

**Precincts 05B & 06 merge into 06**  
**Precincts 05 & 05C merge into 05**  
**Precincts 08 & 08A1 merge into 08**  
**Precincts 13A & 14A merge into 13A**  
**Precincts 17A & 17B merge into 17A**  
**Precincts 18 & 19 merge into 18**  
**Precincts 19All & 20 merge into 20**

**Precincts 05 & 05A – Consolidated**  
**Precincts 06A & 07 – Consolidated**  
**Precincts 08 & 08A – Consolidated**  
**Precincts 10, 10A & 11A – Consolidated**  
**Precincts 17 & 17A - Consolidated**

**NOW THEREFORE BE IT ORDAINED** by the Jackson Parish Police Jury in legal session convened this 4<sup>th</sup> day of August, 2014, that this ordinance be adopted on motion by Mr. Treadway duly seconded by Mr. Garrett and by the following vote:
