

The Jackson Parish Police Jury met in special session Tuesday, June 3, 2014, at 5:00 PM in the Dr. Charles H. Garrett Community Center in Jonesboro, Louisiana. Members present: Mr. Todd Culpepper, Mr. Eddie Langston, Mr. Billy Bryant, Ms. Maxie Monroe, Mr. Charles Garrett and Mr. Lynn Treadway. Absent: Mr. Josh Peterson.

The meeting was called to order by the president, Mr. Culpepper. The invocation was given by Mr. Treadway and Mr. Bryant led the recitation of the Pledge of Allegiance.

The following items were offered for amendments to the agenda:
Purchase of .77 acres located on LA 4 from Randy Ewing at the appraised value of \$6,000.00.
Approve quotation of LaGrandier Fencing for Zoar bin site in the amount of \$1,580.00
Approve medical leave request of Paul Adkins.
There were no public comments on the amendments.

Motion Mr. Treadway seconded Mr. Bryant to amend the agenda to include:
Purchase of .77 acres located on LA 4 from Randy Ewing at the appraised value of \$6,000.00.
Approve quotation of LaGrandier Fencing for Zoar bin site in the amount of \$1,580.00
Approve medical leave request of Paul Adkins.

The president called for public comments; there were none.

Mr. Treadway gave the report of the Solid Waste Committee:

"Solid Waste Committee
May 29, 2014

The Solid Waste Committee met Thursday, May 29, 2014, at 12:00 PM in the Police Jury Meeting Room of the Jackson Parish Courthouse. Members present: Mr. Langston and Mr. Treadway. Absent: Mr. Peterson. Also present: Mr. Culpepper, Mr. Bryant, and Ms. Monroe.

The meeting was called to order by the chairperson, Mr. Treadway. Mr. Langston gave the invocation and Mr. Culpepper led the recitation of the Pledge of Allegiance.

Ms. Angie Johnson addressed the committee about the removal of solid waste bins on LA 810 after an incident where one of the bins had been pulled into the middle of LA 810 on the evening of May 12th. She requested that the bins be returned to the location to serve the residents of LA 810 and those living on that area of Caney Lake.

Motion Mr. Langston seconded Mr. Treadway to recommend that the Jury approve the temporary replacement of 2 bins at the LA 810 location until improvements at the Zoar bin site can be completed and at that time the LA 810 bin location will be permanently closed. Motion carried.

Motion Mr. Langston seconded Mr. Treadway to adjourn. Motion carried and the meeting adjourned at 1:30 PM."

Motion Mr. Garrett seconded Ms. Monroe to reject and not accept the minutes and recommendations of the May 29th committee meeting as read and to permanently close the solid waste bin site located on LA. 810. Motion carried.
