

The Jackson Parish Police Jury met in special session Monday, April 28, 2014, at 5:30 PM in the Dr. Charles H. Garrett Community Center located at 182 Industrial Drive, Jonesboro, Louisiana. Members present: Mr. Todd Culpepper, Mr. Eddie Langston, Mr. Josh Peterson, Ms. Maxie Monroe and Mr. Lynn Treadway. Absent: Mr. Billy Bryant and Mr. Charles Garrett.

The meeting was called to order by the president, Mr. Culpepper. The invocation was given by Mr. Treadway and Ms. Monroe led the recitation of the Pledge of Allegiance.

Motion Ms. Monroe seconded Mr. Langston to reject all bids for the Chatham Branch Library furniture, shelving, architectural woodwork and office furniture. Motion carried.

Motion Mr. Treadway seconded Mr. Peterson to re-advertise for purchase of library furniture, shelving, architectural woodwork and office furniture for the Chatham Branch Library. Motion carried.

Motion Ms. Monroe seconded Mr. Peterson to accept the bid of Jay Mallard Ford in the amount of \$32,974.00 for the purchase of a three-quarter ton Ford F250 diesel to be paid from the road fund. Motion carried.

Motion Mr. Langston seconded Ms. Monroe to approve the final payment of \$4,990.08 to Aillet, Fenner, Jolly & McClelland for the Rome / Grigsby Road Local Safety Grant Program. Motion carried.

Motion Ms. Monroe seconded Mr. Peterson to submit a formal offer to purchase .77 acres of property on La. 4 not to exceed the appraised value for the purpose of constructing a model bin site. Motion carried.

Motion Mr. Treadway seconded Ms. Monroe to approve the payment of \$350 to Babcock Appraisal Services. Motion carried.

Motion Ms. Monroe seconded Mr. Peterson to approve the payment of \$7,556.45 to Community Financial for the 2014-2015 Landfill Hazardous Liability Insurance policy. Motion carried.

Motion Mr. Langston seconded Ms. Monroe to approve the request of Courtney Whitehead to use the community center parking lot on Saturday, September 13th for staging a 5K run to raise funds for the American Stroke Association. Motion carried.

Motion Mr. Langston seconded Mr. Peterson to approve the quote of Otis Elevator for the installation of an access keypad for the rear entrance of the courthouse lobby in conjunction with the courthouse security system. Motion carried.
