Motion Mr. Treadway seconded Mr. Langston to amend the agenda to include suspending the process of accepting roads into the parish road system. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to recommend that the jury suspend the process of accepting roads into the parish road system until the jury adopts the amended Road Ordinance and Subdivision Ordinance. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to authorize the road superintendent to have a dead tree in the right of way of Louvera Lane removed. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to authorize the road superintendent and the engineer to size a culvert on Hummingbird for drainage issues. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to recommend that the jury approve the Letter of Request of the Watershed Commission for patching the parking lot at the public boat launch. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to recommend that the jury adopt the Driveway Culvert Policy as presented by the road superintendent. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to recommend that the jury adopt the Driveway Culvert Application Form as presented. Motion carried.

Motion Mr. Treadway seconded Mr. Langston to adjourn. Motion carried."

Motion Mr. Treadway seconded Ms. Magee to approve the minutes and recommendations of the April 24, 2017 road committee meeting. Motion carried.

The jury recognized Mr. Mark Day, a resident on Arbin Culpepper Road and his attorney Jeffrey Guerriero. They discussed the disputed right of way on Arbin Culpepper Road that has suspended the jury's clearing and grubbing of the road.

Motion Ms. Monroe seconded Mr. Treadway to allow Mr. Day and his attorney fourteen (14) days to negotiate with another property owner for the purchase of right of way on Arbin Culpepper Road. Motion carried with Mr. Culpepper and Ms. Magee voting against.

The vice president opened the floor for public comments. Mr. Chad Bates discussed Koonce Road, and asked the jury to consider taking Koonce into the parish road system if or when the suspension of taking new roads into the system was lifted.

Ms. Sylvia Baker urged the jury to not rush a decision on Arbin Culpepper Road because of the complexity of the issue.
