

Jackson Parish Recreation District Board Meeting Minutes
September 20, 2021
Jonesboro, Louisiana

The Jackson Parish Recreation District met in regular session on Monday, September 20, 2021 at 6:00pm in the Jackson Parish Golf Course Banquet Room, 524 Club House Drive, Jonesboro, Louisiana. Members Present: Mr. Brent Barnett, Mr. Ricky Cash, Mr. Brandon Lamkin, Mr. Rodney Potts, Mr. Sullivan Stevens and Mr. Chris Womack. Absent: Mr. Jeff Hairston.

The President, Mr. Barnett, called the meeting to order. The invocation was given by Mr. Cash and Mr. Barnett led the recitation of the Pledge of Allegiance.

Mr. Barnett opened the floor for public comments. There were no public comments.

Motion Mr. Cash seconded Womack to approve minutes and financials (August). All in favor. Motion carried.

Motion Mr. Cash seconded Mr. Potts to accept bid from TJ Bond Construction, LLC. for golf course spillway in the amount of \$58,000. All in favor. Motion carried.

Mr. Smith gave board update on some of the ongoing programs at the sports complex including archery/shooting range, flag football, soccer and basketball. The 1st Annual Stephen Morgan Memorial Archery Shoot was held on September 18th with 57 shooters participating. Flag football and soccer will be played every Tuesday and Thursday in the month of October at 6:00pm at the sports complex. There will be no charge for flag football and soccer. Basketball and cheerleader signup will begin in the month of November. In the Spring, there will be a golf and tennis clinic and a kid fishing tournament at the golf course.

Ms. Williams gave board update on the golf course including membership and banquet rentals. The rental contract will be updated to include 12am ending time for events. A staff member will be present to enforce time. A metal gate will be placed at the front entrance of the golf course and will be locked at dark except for events. Signs will be posted with times.

Motion Mr. Barnett seconded Mr. Potts to advertise for thinning to the highest bidder to select cut, chip and remove debris from golf course. All in favor. Motion carried.

Motion Mr. Potts seconded Mr. Cash to approve Cooperative Endeavor with the Town of Chatham in the amount of \$10,000 for the improvement of the recreational area around Chatham Lake. All in favor. Motion carried.

Mr. Dewayne Harrell discussed lease renewal and the need for a new mower. He will compare prices and get quotes to present to the board.

The board discussed golf course fees with no changes made.

Motion Mr. Barnett seconded Mr. Potts to adjourn meeting. All in favor. Motion carried.
