The Jackson Parish Police Jury met in regular session on Tuesday, August 4, 1987, with the following members present: Rodney Alexander, Johnny McCarty, David McManus, Huey Massey, Roger Young, Ross Pullin, Kennie Bowman, Troy Smith, Lamarr Davis, and James Bradford.

The meeting was called to order by the President and the invocation was given by Mr. Bowman.

Mr. Quinton Causey, Mayor of Hodge, came before the Jury to request that the Jury create a Hodge Fire Protection District composed of Ward 8 and portions of Wards 9 and 10.

Motion Mr. Smith seconded Mr. Davis to create the Hodge Fire Protection District:

HODGE FIRE PROTECTION DISTRICT

WHEREAS, the Jackson Parish Police Jury after a public hearing held on the 4th day of August, 1987, after disposing of all objections of all persons in authorities hereby resolves,

WHEREAS, the Hodge Fire Protection District is hereby created and be it further resolved that the boundaries of the Hodge Fire Protection District are fixed as follows:

Beginning at the northeast corner of Section 3, R3W, T15N, thence west on the northern section lines of Sections 3, 4, 5, 6, R3W, T15N, continuing west on the northern section lines of Sections 1, 2, and 3, R4W, T15N, to the junction with the Jackson-Bienville Parish boundary to junction with the southwest corner of Section of 27, R4W, T15N, thence east on the southern section lines of Sections 27, 26, and 25, R4W, T15N, to the southwest corner of Section 25, R4W, T15N, thence east on the southern section line of Section 30, R3W, T15N, to junction with the corporate limits of the Town of Jonesboro, thence north, thence east on said corporate limits to junction with U. S. Highway 167, thence north on U. S. Highway 167 to the junction with the southern section line of Section 19, R3W, T15N, thence east on the southern section line of Sections 19 and 20 to the junction with LA Highway 542, thence northeast on LA Highway 542 to the southwest corner of Section 15, R3W, T15N, thence east on the southern section line to the southeast corner of said section, thence north on the eastern boundaries of Sections 15, 10, and 3, R3W, T15N, to the northeast corner of Section 3, R3W, T15N, which is the point of beginning.

WHEREAS, that after hearing the Police Jury of Jackson Parish does hereby adopt the Hodge Fire Protection District and the same be and is hereby final and conclusive as to said Fire Protection District and Jackson Parish.

WHEREAS BE IT FURTHER RESOLVED, that notice of the formation of the Hodge Fire Protection District should be immediately given by one (1) publication in THE JACKSON INDEPENDENT as the case may be.

Motion carried.

Motion Mr. McCarty seconded Mr. Bowman to create the District 2 Fire Protection District:

DISTRICT 2 FIRE PROTECTION DISTRICT

WHEREAS, the Jackson Parish Police Jury after a public hearing held on the 4th day of August, 1987, after disposing of all objections of all persons in authorities hereby resolves,

WHEREAS, the District 2 Fire Protection District is hereby created and be it further resolved that the boundaries of the District 2 Fire Protection District are fixed as follows:

Beginning at the Jackson Parish-Lincoln Parish boundary, and the junction with the northeast corner of Section 23, R3W, T17N, thence south on the eastern section lines of Sections 23, 26, 35, R3W, T17N to the southeast corner of Section 35, R3W, T17N, thence continue south on the eastern section lines of Sections 2, 11, 14, 23, 26, and 35, to the southeast corner of Section 35, R3W, T16N, thence due east on the southern section line of Section 36, R3W, T16N, continuing on the southern section line of Sections 31, 32, 33, 34, 35, 36, R2W, T16N, continuing on the southern section line of Sections 31, 32, and 33, R1W, T16N, to the southeast corner of Section 33 R1W, T16N, thence north on the eastern section line of Section 33, R1W, T16N, continuing northerly on the eastern section line of Section 28, R1W, T16N, to the northeast corner of Section 28, R1W, T16N, thence west on the northern section line of Section 28, R1W, T16N, to the northwest corner of Section 28, R1W, T16N, thence north on the western section line of Section 21, R1W, T16N, to the northwest corner of said section, from said point continue due east on the northern section line of Section 21, R1W, T16N, continuing on the northern section line of Sections 22, 23, 24, R1W, T16N, continue east on the northern section lines of Sections 19, 20, and 21, R1E, T16N, to junction with the Jackson Parish-Ouachita Parish boundary, thence north on parish boundary to the northeast corner of Jackson Parish, thence west on the Jackson Parish-Lincoln Parish boundary, thence south on Jackson Parish-Lincoln Parish boundary to the northeast corner of Section 23, R3W, T17N, which is the point of beginning.

WHEREAS, that after hearing the Police Jury of Jackson Parish does hereby adopt the District 2 Fire Protection District and the same is hereby final and conclusive as to said Fire Protection District and Jackson Parish,

WHEREAS, BE IT FURTHER RESOLVED, that notice of the formation of the District 2 Fire Protection District should be immediately given by one (1) publication in THE JACKSON INDEPENDENT as the case may be.
Motion carried.

Motion Mr. McCarty seconded Mr. Young to appoint Joe Boyd and E. L. Lewis as commissioners for the District 2 Fire Protection District. Motion carried.

Motion Mr. McManus seconded Mr. Smith to create the District 3 Fire Protection District:

DISTRICT 3 FIRE PROTECTION DISTRICT

WHEREAS, the Jackson Parish Police Jury after a public hearing held on the 4th day of August, 1987, after disposing of all objections of all persons in authorities hereby resolves,

WHEREAS, the District 3 Fire Protection District is hereby created and be it further resolved that the boundaries of the District 3 Fire Protection District are fixed as follows:

Beginning at the northwest Section 6, R1W, T15N, thence south on the western section line of Section 6, R1W, T15N, and Sections 7, 18, 19, and 30, R1W, T15N, to the southwest corner of Section 30, R1W, T15N, thence east on the southern section lines of Sections 30, 29, and 28, R1W, T15N, to the southeast corner of Section 28, R1W, T15N, thence south on the western section line of Section 34, R1W, T15N, to the southwest corner of said section, from said point continue due south on the western section lines of Sections 3, 10, 15, 22, 27, and 34, R1W, T14N, to junction with the Jackson Parish-Winn Parish boundary, continue east from said point to junction with the southeast corner of Jackson Parish, continue from said point north, thence northwest to junction with the northeast corner of Section 19, R1E, T16N, thence west on the northern section lines of Sections 21, 20, and 19, R1E, T16N, and of Sections 24, 23, 22, and 21, R1W, T16N, to the northwest corner of Section 21, R1W, T16N, thence south on the western section line of Section 21, R1W, T16N, thence east on the southern section line of Section 21, R1W, T16N, to the northwest corner of Section 27, R1W, T16N, thence southerly on the western section line of Sections 27 and 34, R1W, T16N, to the southwest corner of Section 34, R1W, T16N, thence west on the northern section lines of Sections 4, 5, and 6, R1W, T16N, to the northwest corner of Section 6, R1W, T16N, which is the point of beginning.
